The Winging It Flight Seminar will be held this year at the La Quinta Inn in Moab, Utah on 23-25 March 2007. We STRONGLY recommend that you reserve your rooms as soon as possible because the Moab area will fill up quickly for this time of year (and I am not kidding). For room reservations at the La Quinta Inn, call (435) 259-8700 and ask for Winging It group rates, deadline is Feb 21, 2007.

This seminar will include both lecture time and field demonstrations. The speakers will include Dr. Susan Friedman, Steve Layman, Barbara Heidenreich, Dean Moser, and Chris Biro. The lectures will start at about 8:00 AM and the field demonstrations will start at about 2:00 PM. We will provide transportation to the field demonstrations. Field demonstrations may require participants to hike about 1.5 miles to the flying location and then back again. Limited viewing will be possible with about 1 mile of hiking. Please bring attire for hiking in cool, windy and wet conditions since the weather can change rapidly in this area. Though we believe the viewing of the birds flying in these field locations is a very important part of this event, no one is required to participate in these field demonstrations if they do not wish to do so. No discounts will be offered for those who do not participate in the field demonstrations. We will provide SIX meals; one sack lunch and one dinner meal per day. Guests may bring their own birds but are not authorized to fly their birds during this seminar (23-25 March) but may register to have our experienced trainers assist them with flying their own personal birds the days of 26-28 March for an additional fee of \$200.00 per day. Guests may also choose to audit (observer only) these training sessions without their birds for \$100.00 per day. Meals are not provided 26-28 March.

# **FREE FLIGHT RELEASE, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT**

In consideration for being permitted to take part in an interactive program presented by Winging It Adventures regarding training parrots to “free fly,” I, on behalf of my heirs, assignees and personal representatives, agree to release, discharge and indemnify Winging It Adventures and its officers, directors, agents and employees, as set out herein:

I expressly acknowledge that engaging in free flight involves risk that my bird(s) may be injured, lost or killed, that I or my bird(s) may be injured by a fellow participant’s bird(s). I acknowledge that Winging It Adventures makes no representations or warranties regarding the success of my free flight efforts. I further acknowledge that the free flight program will take place outdoors on varied terrain and as such presents risks of falling, injury, exposure to the elements and wildlife. Notwithstanding these risks I voluntarily choose to participate in the free flight program and accept all risks associated with doing so.

I hereby waive, on my behalf and on behalf of anyone who claims to act on my behalf, any and all rights and claims for damages, losses, injury and any other action whatsoever, which I may have or which may arise against Winging It Adventures, or its agents, employees, directors or officers, for any loss or injury of any kind whatsoever I or my bird may suffer as a result of participating in the free flight program. On behalf of myself and my executors, administrators, assignees and heirs, I hereby expressly Release Winging It Adventures and its agents, employees, directors and officers from any and all such claims.

If I or my parrot shall injure anyone, or damage another’s property, I agree to indemnify, hold harmless and defend Winging It Adventures from and against any and all suits, claims or actions, including all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with my or my bird(s) activities.

This agreement and any matter arising out of the free flight program shall be construed and interpreted in accordance with the laws of the State of Oregon, and any lawsuit pertaining to this agreement shall only be filed in the Multnomah County Circuit Court, Portland, Oregon, to the exclusion of all other Courts.
